INTRODUCTION

The following information may be helpful to the user of this index.

At the time these deeds were recorded the County Seat of Justice was at Bellefonte, AL. The land area of the county was bounded on the east and south by the Tennessee River. The Tennessee state line was the north boundary line. The Flint River was the western boundary line. Some of the individuals named in this index lived in areas that are in Madison and Marshall Counties in 1994.

A loose sheet inserted between page 20 and 23 (original pages 21 and 22 are missing) shows a document dated January 22, 1831. The sheet must have come from an earlier deed book. The original book is stored in the "Little Courthouse" at the Heritage Center in Scottsboro, AL. A copy is available for research.
