Missing Deed Books Preface

There are deed books in the Jackson County Courthouse labeled: A, B, C, D, E, F, G, and H. During 1993 and 1994, Judge R.I. Gentry had these books and other county records, reproduced in a uniform sized plastic binding. These books are available for use in the Jackson County Courthouse. Some of these books had self-contained indexes giving the Grantee and Grantor; Direct & Reverse. Some of the books had been indexed in a master index. The original deed books were assigned or lent to the "Little Courthouse" at the Scottsboro-Jackson Heritage Center.

To make the information in these deed books available to historians and genealogist, the volunteer staff at the Scottsboro-Jackson Heritage Center has undertaken the time consuming task of making a full name index for each deed book. The index in most deed books presents only the Grantor and the Grantee. We have listed each name found in each deed. Many times the deeds included the spouses and children of the Grantor, the former owners of the property, geographical features, names of adjoining property owners and many other bits of information useful to the genealogist. In these new indexes a certain amount of other useful information is included in the introduction of the index.

It is thought that some time after the War Between the States, many of the deed books were rebound. It appears that the binder of the book did not make any effort to label the books in alphabetically and chronological order. The following information will show this confusing discrepancy.

Why are there two deed books for the same time? There is very little correlation between the names in the two books from the standpoint of Grantor and Grantee. Richard B. Clayton, Clerk of County Court, signed documents in both books but rarely on the same day.

Where are these missing deed books? Were they burned at Bellefonte with the Courthouse? Were they removed from the Courthouse at the approach of the Union Army? Were they accidentally or deliberately destroyed during the chaotic times at the end of the war? Were they lost during the transfer of the county records from Bellefonte to Scottsboro in the fall of 1868? Will someone find them at a future date in their attic, or in the courthouse basement storage, or in a private law library?

Beginning in November of 1863, the records of the Probate Court were moved to the residence of George Sublett. This residence was on the east or south side of the Tennessee River at Sublett's Ferry. (Probate Court Minutes Book B, Page 414)

The Commissioner's Court was concerned about the Probate Court record as shown in Road Book Three, Page 410. All the August 16, 1865, meeting of the Commissioner's Court the first order of business was "...to secure a suitable room in the town of Bellefonte in which the business of the Probate Court can be transacted and the records and papers of the office secured."

The Grand Jury for the Fall term of Circuit Court reported to the Honorable W.J. Haralson, Judge of the Fifth Judicial District, that "the courthouse of said county was destroyed during the war and there is no building at the Seat of Justice suitable to hold court in." (Circuit Court Minutes, Book C.)

The Grand Jury further reported that "they had not been able to examine the conditions of the County Treasurer's office because the books thereof were removed at the approach of the Federal Troops, and as this body is informed were lost or destroyed during the late war."

It is my opinion that beginning in the summer of 1830, Deed Book A was the first book for recording deeds. When Book A was filled, Book B was started until all the letters A through Z were used. Some of these books were burned at the end of the war.

Sometime after the war, the surviving Deed Books were rebound. The binder did not pay much attention to the dates in the books as they were labeled. The binder had enough pages to make seven volumes. The seven books were labeled A through G. The deeds for the Post-Civil War years were given the label H.

The following fact may provide a little more information about the subject being considered. From the existing deed books, we find this information:

INTRODUCTION

In Deed Book A, the recording of each indenture usually required two or three pages. In this Index the page number following the name of a party to each deed represents only the first time the name appears in that indenture. Any subsequent numbers indicate that that person was a party to more than one indenture.


Certain county officials, who must sign each document, have only the first page number listed on which their names appear. Any subsequent page numbers indicate these officials were also parties to indentures. These officials are:

Thompson N. Rector, Judge of County Court
Moses Jones, Clerk of Circuit Court

The last names of Justices of the Peace are followed by the initials "J.P." These Justices' names may appear several times but the number following the name is the first time they appear as a Justice of the Peace. Any subsequent numbers indicate these Justices were also parties to an indenture.

The first 56 pages of DEED BOOK A are missing.

This Indenture made this the sixteenth day of December in the year of our Lord one thousand eight hundred and thirty nine between Warren P. Roberts, Alfred Moore, and Eldred W. Williams, Paint Rock Commissioners, and Samuel Mead all being of Jackson County, State of Alabama, Witnesseth that in and for the sum of two hundred and fifty dollars in hand paid the said Samuel Mead by W.P. Robertson, Alfred Moore and E.W. Williams,

Commissioners, as aforesaid the receipt whereof is hereby acknowledged the said Samuel Mead in consideration of the above hath this day bargained sold aligned enfeoffed and relinquished and by the presents doth bargain sell enfeoff and relinquish unto the aforesaid Commissioners forever the right and privilege in his Mill Dam situated on Paint Rock River on the following tract of land (Viz.) South East quarter of Section 10 Township Four Range Three East the said right and privilege described as follows (Viz.) twelve feet in said dam to be kept upon to low water mark for the free passage of keel boats when they can run ascending or descending by a good and substantial lock and keep the same in good repair for the space of five years also thirty additional feet in said Mill dam to be reduced to six feet for the purpose of allowing passage of flat boats at such times when they can run said thirty feet to be used by said Mill at such times when flat boats cannot run . The said Samuel Mead hath hereby in consideration of these presents warrants and will forever defend the aforesaid right and relinquishment unto the said W. P. Robertson, Alfred Moore, and E.W. Williams, Commissioners as aforesaid and their successors from and against himself and each and every person or persons claiming or holding under him in any manner whatsoever. In witness whereof I have hereunto set my hand and seal the day and date before written witnesseth
